UT MARTIN TO HOST TENNESSEE COURT OF CRIMINAL APPEALS APRIL 20

UT Martin will host the Tennessee Court of Criminal Appeals, April 20, in the Boling University Center's Watkins Auditorium. The court will hear oral arguments in three cases beginning at 9,

10 and 11 a.m. Proceedings are open to the public, but entry and exit will be limited between cases.

The state of Tennessee has two intermediate-level appellate courts, the Court of Appeals and the Court of Criminal Appeals. The Court of Criminal Appeals, created by the Tennessee General Assembly in 1967, hears trial court appeals in felony and misdemeanor cases, as well as post-conviction petitions. The court has 12 members who sit in panels of three and meet monthly in Jackson, Knoxville and Nashville. The court may meet in alternate locations.

Court of Criminal Appeals hearings do not include witnesses, juries or testimonies. Instead, attorneys from both sides present either oral or written arguments. On April 20, participating attorneys in each case will have 20 minutes to present oral arguments, and the remainder of each hour has been allotted to answer questions from UT Martin students.

The panel meeting on the UT Martin campus will include Judge John Everett Williams, Judge Camille R. McMullen and Judge J. Ross Dyer from the Court of Criminal Appeals. Judge Williams is a UT Martin graduate.



You Tell Me

- Question The seating repairs on the east side of Hardy Graham Stadium were completed in 2021. However, the Moody Street side of the building that houses ROTC still appears to be a construction zone. Are the stadium repairs completed, and what work remains in the area occupied by ROTC? Or is there more work to be completed on the stadium side?
- •Answer Probably six months after the bleacher risers were repaired on the visitors side of the ROTC Building, additional damage to the brick was discovered on the building's east façade. For safety reasons, the Physical Plant immediately fenced off the area and contacted a structural engineer. After months of back and forth with our engineers and insurance providers, the university has settled on a dollar amount for what turned out to be additional earthquake damage. At present, the university has an architectural firm working on repair options that will fit the budget. Hopefully, a plan for the repairs will be available in the next couple of months.
